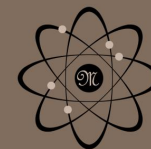

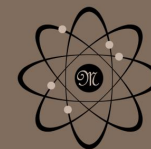

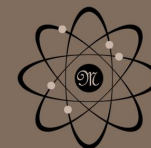


WHAT IS AN ADVISOR FOR?

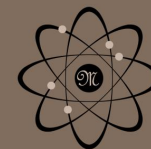


WHAT IS AN ADVISOR FOR?

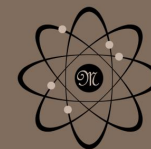


WHAT IS AN ADVISOR FOR?

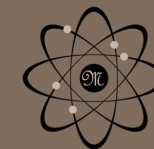

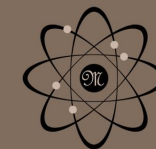


WHAT IS AN ADVISOR FOR?
